M/S GREEN E-WASTE PVT LTD, Tiruvallur, authorized by Tamil Nadu Pollution Control Board (TNPCB) – Authorization No. T10/E WASTE / TNPVB/F.EW26/AMB/2014:Dt10.12.2014 under E-Waste (Management and Handling) Rules, 2016 enacted under environment (protection)Act, 1986 thereof, having its refinery situated at SF No. 394/1, Ayanambakkam village,

GREEN is engaged in the business of collection, reception, storage, transportation, treatment, disposal of e-waste including junked computers, electrical and electronic components. GREEN is registered and authorized by Tamil Nadu Pollution Control Board,

And

MAHER is a teaching institution having nine constituent colleges under its ambit. The Institute has state of art infrastructure which is constantly upgraded. In this process, e- waste is generated in the institute which needs to be disposed in a responsible manner.

Now, therefore in consideration of the mutual covenants and obligations set forth herein by the parties hereto it is agreed as follows:

1. MAHER hereby agrees to dispose e-waste (scrap computers and its accessories, electrical & telecommunications components, all electrical and electronics related scraps) to GREEN for disposing in an environment friendly manner.
2. GREEN shall pay a sum of Rs.15 /kg excluding GST to MAHER for mixed e- waste collected from MAHER.
3. For disposal of hazardous waste including chemicals, MAHER shall pay a sum of Rs. 15/ kg excluding GST to GREEN.
4. GREEN shall ensure to take all the necessary safety precautions while transporting the e-waste from the MAHER to their premises.
5. GREEN should furnish Form 6 as an acknowledgement for transporting e-waste from MAHER and give Certificate of Recycling to MAHER within 90 days of collecting the e-waste.
6. GREEN shall ensure that e-waste lifted from the MAHER shall be disposed in an environment friendly manner and as per the guidelines of TNPCB.
7. MAHER shall inform GREEN to lift /clear the scrap materials from their premises as and when accumulated and the GREEN shall lift/clear the materials within 72 hours of receiving the information. Information has to be sent to the GREEN through email or official letter addressed to M/S GREEN E-WASTE PVT LTD, Plot No.33, Geeson Colony Galaxy Road Kil Ayanambakkam Village, Ambattur, Chennai, Tamil Nadu 600095.
8. GREEN shall ensure that no legal complication arises in handling the e-waste after lifting the same from MAHER. If any legal complications arise, GREEN shall handle it with its own

9. MAHER shall not dispose the e-waste to any other party other than the GREEN till this agreement is in force.

10. In the event of any dispute or interpretation of this agreement the parties herein shall refer the matter to an arbitrator in Chennai, to be mutually appointed by the parties herein.

11. Unless terminated, this agreement shall be valid for a period of five years, from the date herein above mentioned. The parties may extend the term for such further period as may be agreed mutually.

12. In the event that either party breaches any of the provisions of this agreement, the other party may terminate this agreement at any time by giving the defaulting party 15 days prior notice of termination in writing.
