Apart from this, please also share couple of names of persons from industry or society keen on evolving this subject. This summit shall provide rich experience and critical exposure to the vision of the Government enabling Bharatiya technology in software and hardware that are developed specifically for the Bharatiya Bhasha and have potential to reach all sections of the society in their respective Bhasha.
