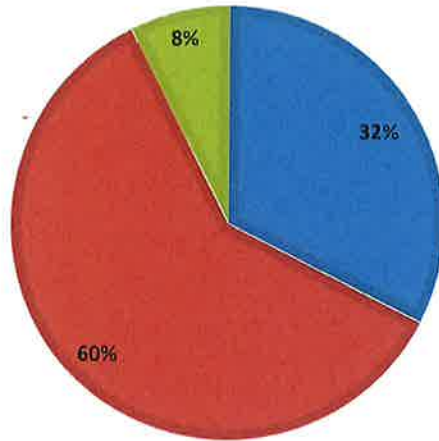
How do you rate relevance of the courses in relation to the program?

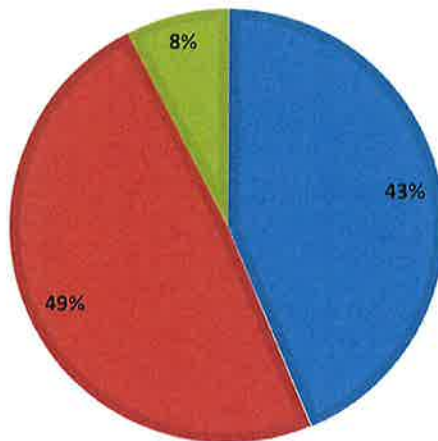
How do you rate the overall curriculum of the courses related to your organizational competency needs?

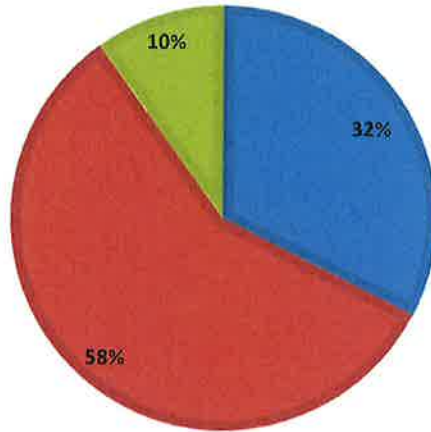
Do you find the competencies and skills from the curriculum developed are relevant to patient/healthcare/industry needs?

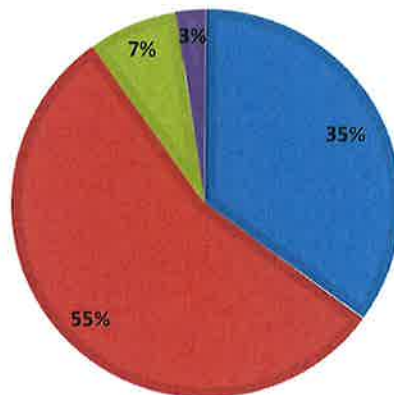
Rate the offering of the curriculum in relation to the specialization streams?

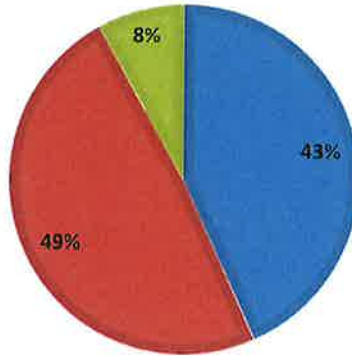

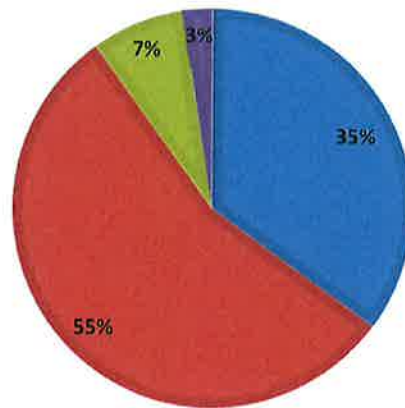

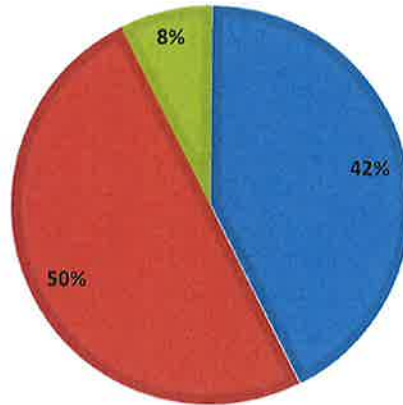

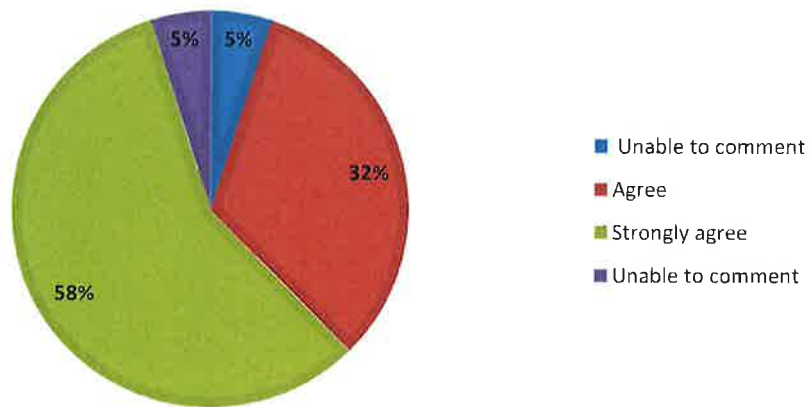


Whether our students working in your organization have demonstrated professional skills including ethics and communication

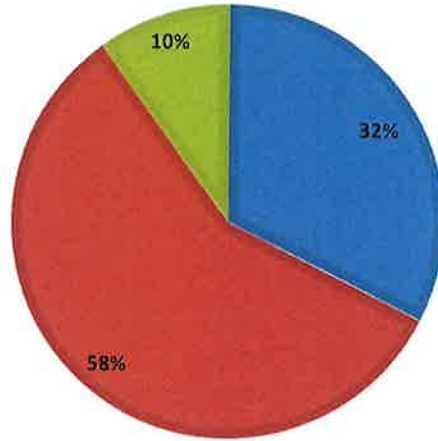


How do you rate the practical knowledge of students in terms of their relevance to the real life application?
